# Fixed Point Result for $a P_{f, g}$-Integral Contractive Mappings with Applications

#### Abstract

Background/Objectives: In this paper, we introduced the concept of $\alpha \mathrm{P}_{\mathrm{f}, \mathrm{g}}$ integral contractive mappings, which is a new class of integral contractive mappings and using this notion we establish a new fixed point theorem. Findings: Our paper represents a generalization and extension of fixed point theorems for mappings satisfying contractive conditions of integral type where the contractive inequality depends on rational and irrational expression. In particular, we omitted the condition of continuity (which is a very strong condition and appear in almost all papers using contractive mapping of rational type) from many existing results. Application/Improvements: As a direct consequence, some new results of integral type for rational and irrational contraction maps are presented to illustrate our obtained result.


Keywords: Fixed Point, Integral Type, $\alpha \mathrm{P}_{\mathrm{f}, \mathrm{g}}$-Integral Contractive Mappings, Irrational Type, Rational Type

## 1. Introduction and Preliminaries

1. In 2002, Branciari ${ }^{1}$ introduced the notion of contractive mappings of integral type in complete metric spaces. Afterwards, many researchers extended this result to more general contractive conditions of integral type providing sufficient assumptions which ensure the existence and uniqueness of fixed points (see for example Gupta and Saxena ${ }^{2}$, Liu et al. ${ }^{3}$, Pathak ${ }^{4}$, Rhoades ${ }^{5}$ and Vishal and Ashima ${ }^{14}$ Vetro).

Throughout this paper, let us consider the following sets:

In 2014, Liu and al. ${ }^{6}$ extended a result established in the paper ${ }^{7}$ by proving the following theorem:

Theorem 1.1. Let $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}, M \in\left\{M_{1}, M_{2}, M_{3}\right.$, $\left.M_{4}\right\}$ and $T$ be a mapping from a complete metric space ( $X$, d) into itself satisfying

$$

Then $T$ has a unique fixed point $a \in X$ such that $\lim _{n \rightarrow \infty} T^{n} x=a$ for each $x \in X$.

Where

$\mathrm{In}^{8}$, Dass and Gupta proved a fixed point theorem by considering a class of mappings where the contractive inequality depends on rational expressions:

$$
d(T x, T y) \leq M_{5}(x, y):=a d(y, T y) \frac{1+d(x, T x)}{1+d(x, y)}+\beta d(x, y),
$$

A generalization of the above contraction was suggested by Gupta and Saxena ${ }^{9}$ (among others, see in particular ${ }^{10}$ and ${ }^{11}$ ) by introducing the following class of mappings:

[^0]$d(T x, T y) \leq a_{1} d(y, T y) \frac{1+d(x, T x)}{1+d(x, y)}+a_{2} \frac{d(x, T x) d(y, T y)}{d(x, y)}+a_{3} d(x, y)$.
Another well-known theorem was established by Jaggi ${ }^{12}$ which may be considered as an extension of the two last results. He considered the following class of mappings:

d(T x, T y) \leq a_{1} \frac{d(x, T x) d(y, T y)}{d(x, y)}+a_{2} d(x, y) .
$$

To prove the main results in ${ }^{9}$ and ${ }^{12}$, authors impose a very strong and unwanted condition: " $T$ is continuous". These results have been generalized in many ways over the years but the condition of continuity appeared in all the subsequent papers using this type of contractions, as an essential condition.

In our paper, we introduce the concept of $\alpha \mathrm{P}_{\mathrm{f}, \mathrm{g}}$ integral contractive mappings, which is a new class of integral contractive mappings and using this notion we establish a new fixed point theorem. This class of contractions extends and generalizes more or less known results including all previous results ${ }^{6,8,9,12}$. In particular, we omit the condition of continuity of the mapping " $T$ " from the main result in ${ }^{9,12}$ (see corollary 1). Moreover, by corollaries 2,3 , we introduce a new class of rational and irrational contractive mappings and give their related theorems.

Throughout this paper, we consider the following notations:

Notation 1.2. Let $f: \mathbb{R}_{+}^{3} \times \mathbb{R}^{*} \rightarrow \mathbb{R}_{+}$be a function. $\Pi_{f(x, y, z, t)}$ denotes the set defined by:

Example 1.3. Let $f: \mathbb{R}_{+}^{3} \times \mathbb{R}^{*} \rightarrow \mathbb{R}_{+}$be a function defined by:

Definition 1.5. Let $f: \mathbb{R}_{+}^{3} \times \mathbb{R}^{*} \rightarrow \mathbb{R}_{+}$be a function. If there exist two functions $g$, $h$ in $r$ such that

for all $X \in \mathbb{R}_{+}^{3} \times \mathbb{R}^{*}$, function $f$ is called $r$ - addmissible.
Notation 1.6. For all $f: \mathbb{R}_{+}^{3} \times \mathbb{R}^{*} \rightarrow \mathbb{R}_{+}$, we denote

Remark 1.7. Let us observethat the following mappings $g_{i}: \mathbb{R}_{+}^{4} \rightarrow \mathbb{R}_{+}:$

Notation 1.8. We denote by $\theta: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$a function satisfying the following conditions
$A_{1}-\theta$ is non-decreasing and the sequence $\left\{\theta_{n}(t)\right\}_{n}$ defined by $\theta_{n}(t):=\theta^{n}(t)\left(n^{\text {th }}\right.$ iterate of $\left.\theta\right)$ is bounded for all $t \in \mathbb{R}_{+}^{*}$. $A_{2}$ - There exists $(\in, r) \in[0,1] \times[1,+\infty]$, for all $(t, \eta) \in \mathbb{R}_{+}^{*} \times$ $[0,1]+\in\left[; \theta(\eta \mathrm{t}) \leq \eta^{r} \theta(\mathrm{t})\right.$.

Remark 1.9. As we can easily verify, condition $\left(A_{2}\right)$ imply that

- for all $a \in \mathbb{R}_{+}$we have $\lim _{t \rightarrow a} \theta(t) \leq \theta(a)$.
- $\theta(0)=0$.
- In particular, $\theta$ is continuous from the right at the point 0 .

Remark 1.10. All (c)-comparison function satisfies conditions $A_{1}$ and $A_{2}$.

Notation 1.11. Let $T$ be a mapping from a complete metric space $(X, d)$ into itself, we denote by $\Gamma(T)$ the set of all functions $\alpha: X \times X \rightarrow \mathbb{R}_{+}$satisfying the following conditions

1. $a(x, y) \geq 1 \Rightarrow a(T x, T y) \geq 1$,
2. $\left.\begin{array}{l}a(x, y) \geq 1 \\ a(y, z) \geq 1\end{array}\right\} \Rightarrow a(x, z) \geq 1$,
3. $\lim _{n \rightarrow \infty} d\left(x_{n^{\prime}}, y_{n}\right)=0 \Rightarrow \liminf _{n \rightarrow \infty} a\left(x_{n^{\prime}}, y_{n}\right) \geq 1$, for all $x, y, z \in X$ and $\left\{x_{n}\right\},\left\{y_{n}\right\}$ nonnegative sequences.

The following lemmas play an important role to obtain our result.
Lemma 1.12. ${ }^{13}$ Let $\varphi \in \Phi_{1}$ and $\left\{r_{n}\right\}_{n}$ be a non-negative sequence with $\lim _{n \rightarrow \infty} r_{n}=a$. Then

\lim _{n \rightarrow \infty} \int_{0}^{r_{n}} \varphi(\mathrm{t}) d t=\int_{0}^{a} \varphi(\mathrm{t}) d t .
$$

Lemma 1.13. ${ }^{13}$ Let $\varphi \in \Phi_{1}$ and $\left\{r_{n}\right\}_{n}$ be a nonnegative sequence. Then

if and only if $\lim _{n \rightarrow \infty} r_{n}=0$.
Lemma 1.14. Let $\varphi \in \Phi_{1}$ and $\left\{u_{n}\right\}_{n},\left\{v_{n}\right\}_{n}$ be two nonnegative sequences such that $u_{n} \leq v_{n}$ for all $n \in \mathbb{N}$ and $\lim _{n \rightarrow \infty} u_{n}$ $=\lim _{n \rightarrow \infty} v_{n}=l \in \mathbb{R}$, then

\lim _{n \rightarrow \infty} \int_{u_{n}}^{v_{n}} \varphi(\mathrm{t}) d t=0 .

Proof. The condition $\lim _{n \rightarrow \infty} u_{n}=\lim _{n \rightarrow \infty} v_{n}=l \in \mathbb{R}$ with the fact that $\varphi \in \Phi_{1}$ means that

This, with lemma 1.12, clearly drives to the result.
Lemma 1.15. Let $\varphi \in \Phi_{1}$ and $\left\{r_{n}\right\}_{n}$ be a nonnegative bounded sequence and $a, b \in \mathbb{R}_{+}^{*}$ such that

for all $n \in \mathbb{N}$. Then

Proof Let $\varphi \in \Phi_{1}$ and $\left\{r_{n}\right\}_{n}$ be a nonnegative bounded sequence. Assume that there exist $a, b \in \mathbb{R}_{+}^{*}$, such that

\int_{0}^{r_{n+1}} \varphi(t) d t \leq \theta\left(\int_{0}^{r_{n}} \varphi(t) d t\right)-a \int_{0}^{b} \varphi(\mathrm{t}) d t .
$$

Taking into account condition $A_{1}$ and the fact that $\left\{r_{n}\right\}_{n}$ is bounded, we get

\int_{0}^{r+t+1} \varphi(t) d t \leq \theta\left(\theta\left(\int_{0}^{r_{1}^{r-1}} \varphi(t) d t\right)\left[1-\left(a \int_{0}^{b} \varphi(t) d t / \theta\left(\int_{0}^{\left.s u p p_{0}\right)} \varphi(t) d t\right)\right)\right]\right)-a \int_{0}^{b} \varphi(t) d t .
$$

Without loss of generality, we can suppose that

\theta\left(\int_{0}^{r_{n}} \varphi(\mathrm{t}) d t\right) \geq a \int_{0}^{b} \varphi(\mathrm{t}) d t
$$

Then, putting $\vartheta_{1}:=1-\left(a \int_{0}^{b} \varphi(\mathrm{t}) d t / \theta\left(\int_{0}^{\left.s u p \mathfrak{r}_{n}\right\}} \varphi(t) d t\right)\right)$ and using condition $A_{2}$, we obtain

\int_{0}^{r_{n+1}} \varphi(\mathrm{t}) d t \leq \vartheta_{1}^{r} \theta^{2}\left(\int_{0}^{r_{n-1}} \varphi(\mathrm{t}) d t\right)-a \int_{0}^{b} \varphi(t) d t .

Continuing in this way, we obtain

\int_{0}^{r_{n+1}} \varphi(\mathrm{t}) d t \leq v_{1}^{\sum_{i=1}^{n-1} r^{i}} \theta^{n}\left(\int_{0}^{r_{1}} \varphi(t) d t\right)-a \int_{0}^{b} \varphi(\mathrm{t}) d t .
$$

From the fact that the sequence $\left\{\theta^{n}(t)\right\}_{n}$ is bounded for all $t, \vartheta_{1}<1$ and $r \geq 1$, we deduce that the right hand side of the last inequality tends to $-a \int_{0}^{b} \varphi(\mathrm{t}) d t$ while $n \rightarrow \infty$, which is a clear contradiction with the fact that $a, b \in \mathbb{R}_{+}^{*}$ and $\varphi \in \Phi_{1}$.

We next define the concept of $\alpha P_{f, g}$-integral contractive mappings:
Definition 1.16. Let $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}, f, g: \mathbb{R}_{+}^{4} \rightarrow \mathbb{R}_{+}$, $a: X \times X \rightarrow \mathbb{R}_{+}$be a functions and $T$ a mapping from a complete metric space $(X, d)$ into itself satisfying the integral inequality:

a(x, y) \int_{0}^{d(T x, T y)} \varphi(\mathrm{t}) d t \leq \theta\left(\int_{0}^{P_{f}(x, y)} \varphi(\mathrm{t}) d t\right)-\int_{0}^{\mu(P g(x, y))} \varphi(t) d t, \tag{1.2}
\end{equation*}
$$

for all $x, y$ in $X$. Then $T$ is called $a P_{f, g}-$ integral contractive mapping.

## 2. Main Result

Theorem 2.1. Let $T$ be an $\alpha P_{f_{1}, f_{2}}$ integral contractive mapping from a complete metric space ( $X, d$ ) into itself, where $\alpha$ is in $\Gamma(T)$ and $f_{1}, f_{2}$ are two $r$-admissible functions. If $a\left(x_{0}, T x_{0}\right) \geq 1$ for some $x_{0} \in X$ then, $T$ has a fixed point $a \in X$ and the sequence $\left\{T^{n} x_{0}\right\}_{n}$ converges to $a$. Moreover, if for all fixed points $x$ and $y$ of the mapping $T$, we have $a(x, y) \geq 1$, the mapping $T$ has a unique fixed point.
Proof. First suppose -without loss of generality- that

$$
\begin{equation*}
x_{n} \neq x_{n+1} \text { and } a\left(x_{n}, x_{m}\right) \geq 1 \tag{2.1}
\end{equation*}
$$

for any positive integers $\mathrm{n}, \mathrm{m}$, where $x_{n}:=T^{n} x_{0}$. On the other hand, by the facts that $f_{1}, f_{2}$ are two $r$-admissible functions, they can be regarded as two elements of $T$ without anyloss of generality.

Now, denoting by $d_{n}:=d\left(x_{n}, x_{n+1}\right)$, let's show that the sequence $\left\{d_{n}\right\}_{n}$ is decreasing to 0 after some rank. For this, assume that for all $n_{0} \in \mathbb{N}$, there exists $\mathrm{n}>n_{0}$ such that $d_{n} \leq$ $\mathrm{d}_{n+1}$. The case $\left\{d_{n}\right\}_{n}$ is an unbounded sequence leads to an obvious contradiction. In fact, considera non-decreasing subsequence $\left\{d_{n_{k}}\right\}_{k}$ with the following properties:

- $d_{n}$ tends to $+\infty$.
- $d_{n_{k}}>d_{n_{k^{-1}}}$ for all $k \in \mathbb{N}$.

Invoking assumptions $\left(\mathrm{H}_{1 a, 1 b, 2 b}\right)$ and relation (1.1) we obtain

& \geq f_{2}\left(0,0, d_{n_{k}}, \frac{1}{2}\left(d_{n_{k}}-d_{n_{k}-1}\right)\right) \\
& \geq \delta_{1} d_{n_{k}}
\end{aligned}
$$

which with the fact that $\psi \in \Phi_{2}$ means

$$

Moreover, due to assumptions $\left(\mathrm{H}_{1 a, 2 c}\right)$ and the first property of the sequence $\left\{d_{n_{k}}\right\}_{k}$ we have

P_{f_{1}}\left(x_{n_{k}-1}, x_{n_{k}}\right) & \leq f_{1}\left(d_{n_{k}-1}, d_{n_{k}-1}, d_{n_{k}}, \frac{1}{2}\left(d_{n_{k}}+d_{n_{k}-1}\right)\right) \\
& \leq f_{1}\left(d_{n_{k}}, d_{n_{k}}, d_{n_{k}}, d_{n_{k}}\right) \\
& \leq d_{n_{k}}
\end{aligned}
$$

The last two results, with the integral inequality (1.2), relation (2.1) and condition $A_{1}$, imply that

\int_{0}^{d_{n_{k}}} \varphi(\mathrm{t}) d t \leq \theta\left(\int_{0}^{d_{n_{n}}} \varphi(t) d t\right)-\int_{0}^{\min \left\{1, \frac{1}{2} \lim _{k \rightarrow \infty} \varphi\left(P_{f_{2}}\left(x_{n_{k}}, x_{n_{k}+1}\right)\right)\right\}} \varphi(\mathrm{t}) d t,
$$

which is in contradiction with Lemma 1.15. Now, returning to identity 1.1 and assumptions $\left(H_{1 a, 2 c}\right)$ we easily obtain

and by assumptions $\left(\mathrm{H}_{1 a, 1 b, 2 a, 2 b}\right)$, we get

Relations (1.1), (2.4) together with assumptions ( $H_{1 a, 2 c}$ ) allow us to write

$$
\begin{aligned}
P_{f_{i}}\left(x_{n}, b\right)= & f_{i}\left(d\left(x_{n}, b\right), d_{n}, 0, \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right) \\
\leq & \max \left\{d\left(x_{n}, b\right), \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right. \\
& \left.f_{i}\left(d_{n}, d_{n}, 0, \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right)\right\} \\
\leq & \max \left\{d\left(x_{n}, b\right), \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right. \\
& \left.f_{i}(\xi, \xi, \xi, \xi)\right\}
\end{aligned}
$$

Where

$$
\xi=\max \left\{d\left(x_{n}, b\right), d\left(x_{n+1}, b\right)\right\}
$$

Therefore

$$
\begin{align*}
P_{f_{i}}\left(x_{n}, b\right) & \leq \max \left\{d\left(x_{n}, b\right), d\left(x_{n+1}, b\right)\right\} \\
& \leq 2 d(a, b) \tag{2.19}
\end{align*}
$$

for sufficiently large values of $n$ and $i=1,2$, which means that the sequence $\left\{P_{f_{2}}\left(x_{n}, b\right)\right\}_{n}$ is bounded. On the other hand, thanks to relations $(1.1)(2.19)$ and assumption $\left(H_{2 b}\right)$ we deduce that

$$
\begin{aligned}
P_{f_{2}}\left(x_{n}, b\right) & =f_{2}\left(d\left(x_{n}, b\right), d_{n}, 0, \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right) \\
& \geq \delta_{5} \min \left\{d(a, b), d\left(x_{n}, b\right), \frac{1}{2}\left[d\left(x_{n}, b\right)+d\left(x_{n+1}, b\right)\right]\right\}
\end{aligned}
$$

from which

$$
P_{f_{2}}\left(x_{n}, b\right) \geq \frac{\delta_{5}}{2} d(a, b)
$$

Then, there exists $a_{5} \in\left[\frac{\delta_{5}}{2} d(a, b), 2 d(a, b)\right]$ such that $\psi\left(a_{5}\right)=\inf _{x \in\left[\frac{\delta_{5}}{2} d(a, b), 2 d(a, b)\right]} \psi(x)$. Now, recalling relations (2.15), (2.16), (2.18) and examining the two cases $d\left(x_{n+1}, b\right) \geq d\left(x_{n}, b\right)$ and $d\left(x_{n}, b\right) \geq d\left(x_{n+1}, b\right)$, we get either

$$
\int_{0}^{d\left(x_{n+1}, b\right)} \varphi(t) d t \leq \Theta\left(\int_{0}^{d\left(x_{n+1}, b\right)} \varphi(t) d t\right)-\int_{0}^{\mu\left(a_{5}\right)} \varphi(t) d t
$$

Or

$$
\int_{0}^{d\left(x_{n+1}, b\right)} \varphi(t) d t \leq \Theta\left(\int_{0}^{d\left(x_{n}, b\right)} \varphi(t) d t\right)-\int_{0}^{\psi\left(a_{5}\right)} \varphi(t) d t
$$

for sufficiently large values of $n$. From where, we get a contradiction with Lemma 1.3. This finishes the proof.

## 3. Application

From the main theorem, we can easily get the following corollaries (we omit its proof for simplicity):

Corollary 3.1. Let $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}$ and $T$ be a mapping from a complete metric space $(X, d)$ into itself satisfying the integral inequality:

$$
\int_{0}^{d(T x, T y)} \varphi(t) d t \leq \int_{0}^{N(x, y)} \varphi(t) d t-\int_{0}^{\psi(M(x, y))} \varphi(t) d t
$$

for all $x, y$ in $X$. Where

$$
N(x, y)=a_{1} d(y, T y) \frac{1+d(x, T x)}{1+d(x, y)}+a_{2} \frac{d(x, T x) d(y, T y)}{d(x, y)}+a_{3} d(x, y)
$$

if $x \neq y$ and $N(x, y)=d(x, y)+d(y, T y)$ if $x=y$, $\left(a_{1}, a_{2}, a_{3}\right) \in \mathbb{R}_{+} \times\left(\mathbb{R}_{+}^{*}\right)^{2}$ are constants with $a_{1}+2 a_{2}+a_{3}<1$ and

$$
M \in\left\{M_{1}, M_{2} . M_{3}, M_{4}, M_{5}, M_{6}\right\}
$$

Then $T$ has a unique fixed point $a \in X$. Moreover, for all $x \in X$, the sequence $\left\{T^{n} x\right\}_{n}$ converges to $a$.

Remark 3.2. This corollary extend both main results in ${ }^{3,9}$ at the case where mapping $T$ is not continuous.

Corollary 3.3. Let $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}$ and $T$ be a mapping from a complete metric space $(X, d)$ into itself satisfying the integral inequality

$$
\int_{0}^{d(T x, T y)} \varphi(t) d t \leq \int_{0}^{N(x, y)} \varphi(t) d t-\int_{0}^{\psi(M(x, y))} \varphi(t) d t
$$

for all $x, y$ in $X$. Where

$$
N(x, y)=\max \left\{d(x, y), \frac{d(x, T x) d(y, T y)}{d(x, y)}, d(y, T y)\right\}
$$

if $x \neq y$ and $N(x, y)=d(x, y)+d(y, T y)$ if $x=y$ and

$$
M \in\left\{M_{1}, M_{2} . M_{3}, M_{4}, M_{5}, M_{6}\right\}
$$

Then $T$ has a unique fixed point $a \in X$. Moreover, for all $x \in X$, the sequence $\left\{T^{n} x\right\}_{n}$ converges to $a$.

Corollary 3.4. L et $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}$ and $T$ be a mapping from a complete metric space $(X, d)$ into itself satisfying the integral inequality

$$
\int_{0}^{d(T x, T y)} \varphi(t) d t \leq \int_{0}^{N(x, y)} \varphi(t) d t-\int_{0}^{\psi(M(x, y))} \varphi(t) d t
$$

for all $x, y$ in $X$. Where

$$
\begin{aligned}
N(x, y) & =a_{1} d(y, T y) \frac{1+d(x, T x)}{1+d(x, y)} \\
& +a_{2} \sqrt{d(x, y) d(x, T x) \frac{d(x, T x)+d(y, T y)}{d(x, y)+d(y, T y)}}+a_{3} d(x, y)
\end{aligned}
$$

if $x \neq y$ and $N(x, y)_{2}=d(x, y)+d(y, T y)$ if $x=y$, $\left(a_{1}, a_{2}, a_{3}\right) \in \mathbb{R}_{+} \times\left(\mathbb{R}_{+}^{*}\right)^{2}$ are constants with $a_{1}+a_{2}+a_{3}$ $<1$ and

$$
M \in\left\{M_{1}, M_{2} . M_{3}, M_{4}, M_{5}, M_{6}\right\}
$$

Then $T$ has a unique fixed point $a \in X$. Moreover, for all $x \in X$, the sequence $\left\{T^{n} x\right\}_{n}$ converges to $a$.

Corollary 3.5. Let $(\varphi, \psi)$ be in $\Phi_{1} \times \Phi_{2}$ and $T$ be a mapping from a complete metric space $(X, d)$ into itself satisfying the integral inequality

$$
\int_{0}^{d(T x, T y)} \varphi(t) d t \leq \int_{0}^{N(x, y)} \varphi(t) d t-\int_{0}^{\psi(M(x, y))} \varphi(t) d t
$$

for all $x, y$ in $X$. Where

$$
N(x, y)=2 a_{1} d(x, T x) \frac{|d(x, T x)-d(x, y)|}{d(x, T y)+d(T x, y)}+a_{2} d(y, T y)+a_{3} d(x, y),
$$

if $x \neq y$ and $N(x, y)=d(x, y)+d(y, T y)$ if $x=y$, $\left(a_{1}, a_{2}, a_{3}\right) \in \mathbb{R}_{+} \times\left(\mathbb{R}_{+}^{*}\right)^{2}$ are constants with $a_{1}+a_{2}+a_{3}<$ 1 and

$$
M \in\left\{M_{1}, M_{2} . M_{3}, M_{4}, M_{5}, M_{6}\right\}
$$

Then $T$ has a unique fixed point $a \in X$. Moreover, for all $x \in X$, the sequence $\left\{T^{n} x\right\}_{n}$ converges to $a$.
